Customer Agreement

In consideration of Classic Home Elements establishing a customer account, the Customer agrees to pay for all items delivered or services rendered to, or at the request of, the Customer, in accordance with the terms of each invoice. The Customer agrees that each of the terms and conditions of sale stated on the invoices shall be a term of the contract of each sale from Classic Home Elements to the Customer. The Customer acknowledges that a monthly finance charge of 1 1/2% per month shall be made on all sums due Classic Home Elements which have not been paid by the payment terms stated on the invoice, and the Customer agrees to promptly pay said finance charge. Waiver of any one or more finance charges shall not be deemed to be a waiver of future finance charges. The Customer further agrees that with regard to such finance charges, the Customer and Classic Home Elements are parties to a written commercial contract. Should it become necessary to place the account with a collection agency or attorney, the Customer agrees to pay all collection costs and attorney fees in addition to all other sums due.

All purchases by the Customer shall be considered made at Classic Home Elements' place of business in Moosic, PA. All agreements between the Customer and Classic Home Elements for the purchase of products will be construed under and governed by Pennsylvania law. Any law suit or cause of action arising out of this or other agreements may be brought by Classic Home Elements, and must be brought by the Customer, in the Court of Common Pleas for Lackawanna County, Pennsylvania or the United States District Court for the Eastern District of Pennsylvania. The Customer expressly consents to jurisdiction and venue in such courts.

The undersigned warrants that the above agreement has been carefully read and that the Customer understands completely. The Customer also warrants that all information provided is true and current.
